Pat wrote and called RVCC requesting a refund of the \$500. At this date, she has not received a response to her requests. She asked the Trustees if they had an ideas about follow up. A discussion followed and it was decided that Pat email Sandy Rumrill about the situation. Pat will also contact Rhonda from the Trustees to see if the situation has been resolved.

Pat received an email from Thomas Pilvelait's mother regarding the Pride Scholarship he received. He will be attending Harvard College in the fall and is requesting that the

scholarship be deferred, as he will need it in the future years. His financial packet is now in place for the first year. We have an official letter dated 8/30/2015.
