# Charlestown Board of Selectmen Budget Hearing Meeting Minutes January 11, 2021 @ 6:30 pm Community Room and Zoom meeting

Chairman St. Pierre called the meeting to order and opened the Budget Public Hearing at 6:30 pm. Mr. Richardson recited the protocol for holding public zoom meetings due to the Covid-19 executive order per the Governor Christopher Sununu. All meetings will be recorded and any motions will be on a roll call for the recording secretary.

Mr. Richardson gave a comprehensive report and read the Town Warrant Articles. A 2021 budget worksheet and a summary of the 2021 budget were thoroughly discussed on Article 5. There was a lot of discussion of areas that were reduced and other areas that were increased. The main reason for the increase in benefits is due to the increase in health insurance and the NH retirement rates increased. Some departments have decided to not fill open positions, or budget a part-time employee instead of full-time. The Police Department will fill its open position later in the year. The Highway Department has opted to not fill two of their positions. There is a new budget line which will be for the first responders. Other decreases and increases have been reviewed.

Mr. Roger Rumrill asked if the Selectboard and Finance Committee would add \$4,500 additional into the training line. This would allow members to take an EMR class to obtain their non transport license that lapsed in 2019. Mrs. Rumrill explained when anyone responds to an emergency scene without this license and an EMT isn't on scene they can not ever provide CPR. They can just "hold their hand" until Golden Cross responds. By taking the class the Town would meet the requirements to increase the numbers needed for the license. Mr. Richardson stated he is open to discuss after the hearing.

The Water and Sewer budget was reviewed and discussed. Both of these budgets are up from 2020. There was discussion if the Water bond does not pass how the arsenic levels will be addressed. Ms. Chaffee answered if the Water bond doesn't pass it doesn't change the fact the Town is responsible for providing safe drinking water. The Town would possibly have to deliver water to North Charlestown and Mr. Shaw has been reviewing filters to address this issue on a short term bases. The filters would be roughly \$200,000. Ms. Francis asked if Ms. Chaffee would have any information if the Town was approved by any grants. Ms. Chaffee stated she is actively working with NH Drinking Trust and USDA. They hope to receive half of the 4.6 million but they need to include the entire amount because the Town does not have any money in hand.

There was a lengthy discussion regarding Article #12 Full-Time Recreational Director. Ms. Chaffee will post the job description on the website.

Article #13 was removed because the Library Trustee has access and authority of these funds.

Ms. Dennis clarified Article #14 and #15 is to clean up the language for the sale of cemetery lots. The Town is currently dividing those payments, but not have properly adopted the statues to do so

The last day to file a petitioned article is tomorrow; January 12<sup>th</sup>

Chairman St. Pierre closed the public hearing at 8:00 pm.
