- There are 3 different funds (Brita Blish, Centennial & Eloise Kinson Fund)
- Long term investments (fairly conservative) receive a check in January for profit made from investments
- Money used for books for the library
- Brita Blish (3000 in principal), generated 284.98 this year
- Centennial (1300 in principal), generated \$123.45
- Eloise (2,892 in principal), generated \$296.86
